Thomas son of Henry le Smyht of Melles to Wm. son of Adam de Lung of Gyslingham, Jr., for a sum of money, a messuage and a piece of land abutting on it with 3 pieces of land with appurtenances, the messuage and croft in the village of Burgate next the land of Henry Almot on the east and land of Mariote Fychet on the west abutting on the north on a road called Mellegrene; and the first piece called Ruggalestayl in the villages of Thornham, Pilcock, and Thornham Parva, next the land of the prior of Eye on the east and the land of Wm. le Smyht on the west abutting on the north on land of Edmund Kneepil, chaplain; the second piece called Shorteland in the village of Thornham Parva, next the land of Richard le Neweman of Melles, and abutting on the west on land of the prior of Eye; third piece called Pyrcelond in the village of Thornham Parva next the land of Robert le Broun on the north abutting toward the west on the pasture of Roger ^{de} Wode.
