Dear Sir:

As an old soldier of the war of 1812 and a resident of the State you so ably represent, I take the liberty of calling your attention to the Bill, lately introduced in Congress, granting a Pension to the soldiers who served in the war of 1812. At the time of said war, I was a resident of Pennsac and I served under General Jackson, through a part of the Creek war and saw some hard fighting.

It is now about forty five years since the war of 1812 commenced and in a few years, at least, all those who participated in the battles of that period, will have reached their final and last journey.

The war of that date was a glorious one; and the Country fully sustained herself and came out of the conflict with the most brilliant success; the result of which can never be forgotten. I am now twenty five years old, and four years more, in all

probability, I shall have passed away.
I suspect, at the end of twenty years, from
this time, few who served in that war
can be the recipients of a nation's gratitude
for the services rendered and the privations
endured by the soldiers in that war.

It appears to me, therefore, no more
than just and right that the Government
or, more properly, the Nation, should in
its gratitude, do something to smooth
down and make comfortable and easy
the last and declining days of those, who,
so nobly endured all the fatigues & privations
incident to war, and whose services tended
to crown the Nation with so much glory.

You must now permit me to say
a few words on the Politics of the day
and the feelings of the people on the most
exciting subject now before Congress.
I am a Democrat, was bred and born
a Democrat, & expect to live and die a
Democrat. I voted for James Buchanan
for President, tho' he was not my choice.
I would not forget the resolution or
position he took in ^{the} country in the
war of 1812, ~~and~~ and am rather inclined
to think that ~~at~~ the best of times was not

altogether of that interesting period.
As regards the Kansas question here, I
believe there is nothing out of harmony,
without distinction of party, that do not
fully endorse a very course and the steps
you have taken in regard to the admission
of Kansas under the Lecompton Constitution.
You are, in my humble opinion, battling
for the right against Executive influence
and power, and I trust in God, that the
right will surely come out in the end,
triumphant.

A great many Democratic meetings have
been held thro' the State on the Kansas question,
and you, ^{at} that, have always been sustained.
Illinois will not, I repeat, own, who has
so long and faithfully served her in the
councils of the Nation, and, I trust, ere long,
that the reward will be forthcoming.

In conclusion I would say that, I trust
you will use your influence in regard to
the Pension Bill. I believe it will be
popular through all parts of the Country &
that it can only be considered as an act
of justice to the "old soldier" - that their
services will rest on those who have used their
influence in the case and respect that justice to them

You will no doubt be somewhat surprised in receiving a communication, from one you were acquainted with, in "days long gone by"; when we were school children in the old Puritan state of Vt. But I trust you will excuse the liberty I have taken in intruding on your time, which at present, is so much occupied in the affairs of the Nation.

The present political crisis, reminds me of the days of Andrew Jackson. I was much edified, in reading your speech of Dec 9th, to see your unwavering, great, & untiring energy, in promoting the cause of Freedom and its institutions. I wish to speak to you on the subject of Revolutionary Claims. —

My husband's father was an Officer and
served through the war, severely wound-
ed, & suffered all the hardships of
the times "that tried men's souls," and
year ago, before his decease, his mem-
orial was placed in the Archives of
the Nation - hoping Congress would
remunerate him for his services -
according to the promise of Gen Washington.
The subject was agitated last year
and defeated. Do you think it has
received its quietus - or is there any
possible prospect of its being brought
into legislation again. I thought I would
write you, knowing you personally, and one so well
versed in affairs of State.

My husband's sister

Mrs John C. Ganger of Ohio, is very anxious, to know
if there is any prospect, anything being done
after so long delay. She would like to know
also, if an individual Obi, was presented
with satisfactory evidence to substantiate
it, would be of any avail. My husband
and Father, Judge Keeler, take much -

interest in your sayings, and doings,
at the present time, should you deem
this worthy your notice, you will com-
passe ^{your} answer, this same. Where are your
Mother, and Sister, are they living. Most of our
family have passed away. We often hear
of your passing through here, on your
way to Chicago, should like very much
to have you stop, and make us a visit.
My kindest regards for yourself
and family - I am your old friend






