



Dear Sir,

I must be pardoned for presuming upon your notice, also for intruding on your valuable time, but we, Democrats of New Hampshire, are peculiarly situated, politically at the present time, as you are aware. Not being represented, as a party, in Congress, we get no favors from our congressional members, either in the Senate or House. For myself, although in times past I used to receive any quantity of "Vat. Doc's.", during the present session I have not received from any member even a copy of a speech with the exception of one from J. P. Hale, and that was far from being at all edifying, as he is far from being a favorite of mine. I know him and all of his antecedents too well!

I have ever carefully watched your congressional course, and am happy

to say that you have even had my
admiration. During your advocacy
of "Toombs' bill" when you were, as you
are aware, most bitterly reviled and
scandalously misrepresented, I, with
what feeble voice and pen that I
could throw into the scale, defended
you at the private circle, on the
"stump" and through the columns of a

in regard to the admission of Kansas under







Yesterday George Gluck, informed that Button had deserted you, was secret Mail Agent in Ill., and in connexion with others endeavouring to establish an administration Paper at Chicago. If this is true I sincerely regret it; I expected better of him and must confess myself deceived in the man.

At the Convention at Cincinnati no one took a more lively spirit or laboured with more assiduity to permeate your interest than Charley Button. And I am, even now, unwilling to believe that any thing save sheer necessity could have induced him to accept office from the hands of Buchanan.

For the estrangement of some of your former friends you can blame yourself, for your neglect of, and want of courtesy towards them had many to construe your conduct in this respect as a species of ingratitude and shabby without any excuse whatever.
