without an effectual amendment
for a change of the Constitution,
free from the control of Calhoun &
(which must be direct intervention)
and thus cause its failure when it
comes back to the Senate.

I regret to notice
your absence from the Senate





Remember, Gentlemen your vote decides that all important question. And if you decree Freedom then God will bless you to the days of your death! But if you vote a slavery constitution on to that people the wrath of God will follow you to your grave! - No, I escape from it if God and the Bible be true! of the God of all our mercies!


