# THE PAPERS OF THE FEDERATION OF AMERICAN SCIENTISTS

## Introduction

The Federation of American Scientists was established on January 6, 1946, as a federation of seven associations of scientists and engineers, including those formed at the Manhattan Project sites of Oak Ridge, Los Alamos, New York, and Chicago. Its purpose, like that of its predecessor, the Federation of Atomic Scientists, was to agitate for the international control of atomic energy and its devotion to peaceful uses, public promotion of science and the freedom and integrity of scientists and scientific research (see Box 1, folder 1, for details). For this purpose, permanent headquarters were set up in Washington, contacts were established with the several branches of the government, the United Nations, professional and private organizations, and influential persons. By 1948, the Federation had grown to comprise twenty local associations, with 2,500 members, had been instrumental in the passage of the McMahon Act and the National Science Foundation, and had influenced the American position in the United Nations with regard to international control of atomic energy and disarmament.

In addition to influencing government policy, it undertook a program of public education on the nature and control of atomic energy through lectures, films, exhibits, and the distribution of literature, coordinating its own activities with that member organizations through the issue of memoranda, policy statements, information sheets, and newsletters.

After 1955, the Federation of American Scientists seemed to go into something of a decline, partly due to the lack of "live" issues, but more substantially due to dwindling revenues. During the middle 'fifties, the original constituent organizations gradually diminished in numbers and vigor, either reconstructing themselves as Federation chapters at a much lower level of activity, or dying out altogether.

The present collection is made up of three parts. The first (1-26) is made up of twenty-six boxes and covers the period from 1945 to 1958. The first three and one-half boxes are devoted to internal affairs, and the remaining to subject files, which include correspondence as well as documents. The original order and denominations have been retained (see Box 3, folder 1). The files on the member organizations have not been segregated, but are to be found in their alphabetical order in the subject files, and contain extensive data on Federation relations with affiliates. Material to be found in the folders ranging from Box 3, folder 2 to Box 4, folder 4 reveal their financial relations. The material in the first section was turned over to the University of Chicago Library for custody in June of 1960, and its use is subject to whatever restrictions the Federation and the University Library may see fit to put upon it. At the same time, the papers of the Washington Association of Scientists and the Association of Scientists for Atomic Education were turned over to the Library, and, because of their completeness, have been organized as separate collections.

The second part (27-66) was given to the Library in January, 1961. Much of the material overlaps that of the first part in time and subject matter. The years covered are from 1946 through 1960. No attempt was made to rearrange the order of the materials; therefore, the

organization is very haphazard. Generally the files are in alphabetical order by subject within a certain time span; but this an over-all order and is not valid in all individual cases. Some files are out of order and some were part of "active" files and so are in no chronological sequence. The subjects given are, wherever possible, those used by the Federation. In some cases, where there was a very small amount of material, more than on subject file has been placed in one folder. Because of the duplication and lack of strict order in the files, the researcher should check all subject headings in both parts of the papers.

The third part (67-69) consists of Federation memos, correspondence, minutes, etc., (1948-4956) collected by Professor Arthur S. Wightman, a member and a treasurer of the Federation, and given to the Library by him in August 1965. Included is some supplementary material not dealing with Federations activities, but on subjects of interest to the F.A.S. For example, there are clippings and documents on the House Committee on Un-American Activities, particularly the E. U. Condon case.

The material has been organized chronologically, with the exception of the following subject headings: Scientists' Committee on Loyalty Problems; Scientists' Committee on Loyalty and Security ; constitution and by-laws; finances and membership; and miscellaneous Federation publications. It should be noted that material on all of these subjects can also be found in the chronological files, in such documents as general memoranda and minutes.

Some interesting subjects appearing in the chronological files are the Oppenheimer case, and the activities of the Committee on Passport Problems, the Committee on the Atomic Pool Plan, the Committee on Disarmament and Atomic Control.
