We find it very difficult to secure a site, but we are at work on the proposition. 



The real estate and buildings now owned and occupied by the discrete Theological Seminary are described in accompanying diagram of the lots on Ashland Boul. on either side of Terren Evenue opposite Union Park, and in photographs, and printed descriptions, to gether with a valuation estimated by Er.
