2. Such conveyance could be made of all of the properties at the present time, or if important, I should think that the conveyances of the different pieces could be made at different times hereafter, on the happening of such events, which it might be thought desirable.

3. The deed or the contract might contain provisions that Rush should continue to operate its undergraduate department until the University had completed its south side plant and erected its south side hospital, and in case there was such a conveyance, there should be proper provision in regard to the appointment of professors granting undergraduate degrees. <sup>TC</sup>

4. Probably it would be best not to have the endowment fund included in the contract or deed, but in the bill filed to obtain the Court's approval of the contract Rush could set up the facts as to the endowment funds and state its willingness to turn them over to the University, if the Court would direct it so to do. Possibly, however, it would be better for Rush to retain them and manage them so as to show that it was not an entirely defunct institution.

Your Committee finds that it is impossible to secure suitable rooms within 3 blocks of the College at this time, either for Library, Recitation or Laboratory purposes. We think it probable that a couple of houses might be rented in the spring at a cost for alterations, rent and running expenses for about \$2000. per year. That would furnish 2 recitation rooms, a laboratory room and a small library. (estimated cost, rent \$960., repairs \$250., janitor \$450., heat, light, water etc., \$320.) With our present accommodations, I am told that we can readily take care of 150 to 170 Freshman Sophomore and Junior students and we can take care of a considerable larger number of Seniors, but according to some of our clinicians we greatly need 4 or 5 clinical rooms that would accommodate classes of from 25 to 50 for the purpose of utilizing our clinical material in the best manner. There is no way to provide these rooms in or about our present buildings. It appears that if our present laboratory facilities could be utilized to their full extent we might easily take care of our classes. ~~No~~

We find on investigation that one of the largest laboratories and one which appears to be most crowded is only occupied 18 hours per week, whereas, there are from 36 to 48 hours that might be utilized. We find that two of the smaller laboratories which are also said to be ~~xxxx~~crowded are only used <sup>10 or</sup> 12 hours per week and that the largest laboratory is only used 8 hours per week. The dissecting room which will, if necessary, accommodate 200 men at a time is used for 18 hours per week for less than half the term. The question arises whether it would not be ~~xxxx~~ possible by dividing the classes into smaller sections and arranging the work differently to utilize the room which is vacant such a large percentage of the time.

There is no room that can be utilized for Library purposes, unless the work of our laboratories can be concentrated in smaller space, but judging from the figures alone, which show that the whole

PLANS OF DEVELOPMENT.

After careful investigation of the graduate plans of Berlin, Vienna, London, Harvard University, Pennsylvania University and Johns Hopkins University, it was decided to adapt the plans of the Graduate School of Medicine of Harvard University, so far as they were adaptable to our larger field, as the basis for organizing the faculty. The Central Free Dispensary of West Chicago and the Trustees of the Rush Medical College of Chicago believing that the work of carrying on a free dispensary in the city of Chicago will be thereby advanced and that the duty of the authorities of the said college under the will of the late John Phillips of Chicago to establish a dispensary will thereby in the interest of humanity be best fulfilled have entered into and do enter into the following agreement to continue ninety-five years (95):

Section 1.-The said Central Free Dispensary agrees to loan to the trustees of the said college eleven thousand dollars (\$11,000) for ninety-five (95) years and to receive interest thereon at the rate of six per cent (6%) per annum payable semiannually. The authorities of the college to give as security for the said loan a first mortgage on their college property which includes the lot (100 by 147 ft.) on the north east corner of Harrison and Wood streets in the city of Chicago and all its buildings and belongings. This loan to be perfected as soon as the college acquires a clear title to the said property. It is further agreed that should at any time one full year pass and the college fail to pay all the interest on the said loan the loan shall if the said Central Free Dispensary so elects be terminated and the full amount of both principal and interest shall then be due and payable.

Section 3.-The said trustees of the said college to the end that they may establish and maintain a free Dispensary in the city of Chicago according to the provisions of the will of the late John Phillips do hereby agree to pay and turn over to the said Central Free Dispensary the whole interest from time to time accruing out of the Phillips Dispensary fund of which they are trustees; that now in their possession to be paid and turned over at once and that in prospect as soon as they shall come to the possession of it. Section 5.-The said faculty by this agreement approve of the By-Laws and Rules of the said Board of Directors of the said Dispensary now in force as rules under which the aforesaid Dispensary may be conducted. But there shall during the continuance of this agreement be no change in said By-Laws that will lessen the amount and character of the Dispensary work done, without the consent of the said faculty, any other change being permitted without such consent. No person shall at any time be appointed Medical Superintendent of said Dispensary work without the consent of said faculty to such appointment.

Section 6.-The Central Dispensary aforesaid shall see that so far as is practicable during the sessions of Rush Medical College, the cases coming to the said Dispensary shall be used by the attending Physicians for clinical purposes and that they - the said physicians give the clinics faithfully and in the interest of sound medical education. The students of the said college shall be admitted to said clinics at all proper times under such rules and regulations as the Directors of the said Dispensary may prescribe. But the said students shall not during the continuance of this agreement be charged any fee for the same without consent of the faculty of the said College.

Section 7.-The Clinical Professors of Rush College shall be allowed to use any of the clinical material of the said Dispensary for clinical purposes in the college rooms provided this shall always be done with the approval of the medical superintendent of the Dispensary, and with the consent of the attending physicians in whose departments where such material shall fall.

Section 8.-This agreement is not intended to deprive the Directors of the said Central Dispensary of any right they now have to establish other dispensary stations in West Chicago than their chief Dispensary.

THIS INDENTURE made the second day of January A. D. 1884, between the Trustees of Rush Medical College, party of the first part, and the Presbyterian Hospital of the city of Chicago, party of the second part, each of said contracting parties being a corporation existing under and by virtue of the laws of the State of Illinois.

Whereas, the Trustees of the Rush Medical College aforesaid, believing that hospitals controlled and managed by religious organizations are most conducive to the interests of the sick, and beneficent in their influence upon society, make the following agreement with the Presbyterian Hospital of the City of Chicago, for the purpose of aiding in the establishment of a hospital of a high order.

Now this indenture witnesseth, that in consideration of the performance of the covenants and agreements hereinafter contained, to be kept and performed by said party of the second part, the said party of the first part hereby covenants and agrees, for itself, its successors and assigns, to convey to the said party of the second part, by good and sufficient Quit Claim Deed, the following described lots, pieces or parcels of land situated in the County of Cook and State of Illinois, viz.: Lots Seventeen (17), Eighteen (18), Nineteen (19) and Twenty (20) in McKay's Re-subdivision of block eleven (11) in Ashland's Addition to Chicago, together with the building now standing thereon, designed for a hospital, upon and towards the completion of which the said party of the first part agrees to expend or to have expended the sum of twenty-five thousand (\$25,000) dollars; also lots Twenty-five (25), Twenty-six (26), Twenty-seven (27) and the west twenty-three and four-tenths (23 4/10) feet of Lot One (1) in McKay's Re-Subdivision aforesaid, subject to a certain mortgage to be made thereon by said party of the first part to Edward L. Holmes, to secure the payment of five thousand dollars (\$5,000), which indebtedness, with the interest accruing thereon, the said party of the second part agrees to pay.

Agreement with Pres. Hospital

A history of the circumstances which resulted in the action of the trustees recorded on page 120 is worthy of note. In 1879, soon after the purchase of a site for the hospital, the question regarding its building and support received the serious attention of the Trustees and Faculty. It was apparent that the college could not carry on the enterprise alone. Dr. Gunn had several interviews with some of the Catholic sisterhoods, who were extremely desirous of building and managing the proposed hospital. After the Trustees had voted to raise Fifteen Thousand Dollars and Tuthill King, Esq. had given ten thousand dollars more, and sisters were still more desirous of assuming ownership and conduct of the hospital and of collecting funds for its future enlargement, with the express stipulation that the college should have absolute control of the appointments on the medical board and of the rules regulating the duties of the staff. Nearly all the faculty was heartily in favor of this arrangement, since all were favorably impressed with the successful management of the Catholic hospitals of Chicago and were acquainted with the satisfactory union of the Mercy Hospital with the Chicago Medical College. Moreover, it was known that the question of the "pathics" in all probability would never arise in the minds of the "sisters" to disturb the harmony of the board, and the union between the college and hospital. Finally, after much discussion, Dr. Ross stated that he believed the Presbyterian churches of Chicago could be induced to form an association which would accept the hospital and its site as a gift and place it on a basis similar to that of the Presbyterian Hospitals of New York and Philadelphia. The plan was successfully matured, the Trustees and Faculty joining unanimously in securing the union. In view of the amount contributed to the hospital by the college and in view of the desirability of having the medical board free for all time from discordant elements, the directors of the hospital vested the control of the medical board, practically, in the faculty. The directors were glad to be relieved of much of the responsibility of forming a medical board and of filling such vacancies as may occur, as is stated in the "agreement." Accordingly, the Medical Board was constituted as nominated by Faculty.

## DEPARTMENTS OF INSTRUCTION.

This school seeks to give instruction to physicians in three distinct ways: *First*, by daily clinical teaching in its dispensary and hospital. This is called the regular clinical course, and it consists in clinical lectures and demonstrations every hour in the day, from 8:30 A.M. to 5 P.M. every day in the year, except holidays. *Second*, by special laboratory, operative and experimental courses; and *Third*, by its monthly publication, THE NORTH AMERICAN PRACTITIONER, a journal of original matter.

#### REGULAR CLINICAL COURSE.

This daily course continues the year through. Tickets are issued at any time. Instruction is given in the order in which clinical material presents itself; but each instructor endeavors to follow out as far as possible the most important or practical points in his subject.

#### GENERAL REMARKS.

The Post-Graduate Medical School of Chicago having outgrown its old quarters in the business center of the city, moved May 1, 1892, to the *Medical Center* of Chicago, 757 and 759 West Harrison St., opposite the Cook County Hospital.

The phenomenal success attained by this school may be attributed to the following facts:

First: Its unlimited clinical facilities.

Second: Its comprehensive and advanced curriculum.

Third: Its large working faculty.

Fourth: Continuous service of a full faculty throughout the entire year.

#### *First—Clinical Advantages.*

The outdoor clinical material which is utilized at the school clinics every day is abundant and rich in rare cases. Six thousand cases were treated during the past year. This material practically illustrates what otherwise would be dead theoretical didactic lectures.

The Post-Graduate Hospital, a part of the institution, conducted on modern aseptic principles, gives the instructors an opportunity to demonstrate on the ground, all phases of treatment, from the simplest prescribing in medicine to the most capital operation in surgery.

Clinics given by the members of the faculty at the various hospitals on allied subjects are arranged so as to conflict as little as possible. Thus a practitioner, desiring to make a study of any particular branch, may profitably occupy himself continuously and exclusively through the day with that particular subject. Or, if he desires, he may select the more interesting demonstrations, operations or other clinics from different subjects.

#### *Second—A Comprehensive and Advanced Curriculum.*

It has always been the effort of this school from its inception to give the practitioner an opportunity, to practically familiarize himself with the modern methods, discoveries and advances of medicine and surgery, which cannot be gained from a cursory reading of medical journals during a busy practice. We seek to instruct as well as entertain. Our laboratories for medical chemistry and toxicology, microscopy, bacteriology and experimental surgery on the lower animals, are well manned and systematic courses in each may be arranged at any time.

#### *Third—Large Working Faculty.*

Our faculty is a working body. No figureheads are allowed to pose as drawing cards, to disappoint students when the work advertised is demanded.

Opposite the school is the great Cook County Hospital, to the public clinics of which our students are admitted without tickets. Profs. J. B. Murphy, R. H. Babcock, Boerne Bettman, W. P. Verity and F. D. Owsley, members of the faculty, hold clinics at that institution.

The Presbyterian Hospital is open to our students through Dr. J. H. Robison. Dr. Newman's operations in gynecology, and Dr. Coleman's eye and ear operations at the St. Elizabeth Hospital are open to our students.

The Illinois Charitable Eye and Ear Infirmary, through the clinics of Dr. Bettman and Dr. Wood, affords a large and very valuable field for those students specially interested in the diseases of the eye and ear.

Operations at St. Luke's performed by Dr. Byford and Dr. McArthur, are regularly bulletined at the college, by which a large amount of interesting work is made available to those interested in gynecology or surgery.

At the Charity Hospital regular clinics are held each week at different hours by Drs. Steele, Trott, Robinson, Coleman, Bacon, Dodds, Hardy, Binkley and Martin. These clinics are all open exclusively to the students of the Post-Graduate School.

At the Woman's Hospital over one hundred and fifty laparotomies and a proportionate number of minor gynecological operations have been performed by Drs. Byford and Martin in the last year. A limited number of practitioners are admitted to these operations—oftentimes in minor cases as assistants.

We seek to fill each department with experienced teachers throughout the entire year and give our very best each day. Students may matriculate, therefore, with equal advantage at any time.

#### *Fourth—Continuous Service of a Full Faculty Throughout the Year.*

The beautiful climate of Chicago during the summer, with its lake breezes, is proverbial, making it a particularly desirable place for physicians from the South and interior to spend the heated season. Our school, unlike the schools of the eastern seaboard towns, continues during the summer with a full working faculty in attendance.

#### *Diseases of the Eye and Ear.*

Dr. Coleman gives two clinics a week, with special reference to external diseases of the eye. Dr. Bettman gives two clinics a week with special reference to functional examination of the eye, fitting of glasses, etc. Dr. Wood gives two hours a week with special reference to ophthalmoscopy. Dr. Francis Dickenson gives two college clinics a week. Dr. Behrens conducts a clinic three times a week for the study of diseases of the eye and ear. On Wednesday and Friday, Dr. Bettman will be in attendance at the Illinois Charitable Eye and Ear Infirmary from 2 to 4 P. M. At this institution five thousand patients are treated yearly. A hospital ticket, however, is required of non-residents of the State of Illinois. Students are invited to visit the County Hospital with Dr. Bettman on Tuesday and Thursday afternoon at half-past two o'clock. Dr. Coleman gives a clinic to which students are invited in St. Elizabeth's Hospital every Thursday from 2 to 4 P. M.

#### *Diseases of Women.*

Every day at half-past nine in the morning a clinic is held by Dr. Newman, Dr. Martin or Dr. Robinson. Dr. Goldspohn holds a gynecological clinic every Friday from 10:30 to 11:30. These clinics afford ample means for careful study of diagnosis and treatment of the various diseases peculiar to women. Clinics are also held at the various hospitals with which members of the faculty are connected. In these clinics major surgical cases are presented for operation, and students are able to examine large numbers of cases and assist in operative procedures under favorable circumstances. Small classes will occasionally be invited to witness or assist at private operations of special interest.

Dr. Byford gives clinics regularly at St. Luke's Hospital on Wednesdays during January, February, March, July, August and September, and special clinics at other times. Clinics will also be given at the Woman's Hospital throughout the year. Laparotomies will be performed before the class.

At the Post-Graduate Hospital Dr. Newman, Dr. Robinson, Dr. Martin or Dr. Goldspohn operate before the class.

Dr. Robinson and Dr. Martin hold each a gynecological clinic every week at the Charity Hospital. Dr. Goldspohn operates at the German Hospital.

Dr. Robinson gives special demonstrations on the pelvic and abdominal viscera, and discusses diagnoses, operative procedures on the intestines, plates for intestinal anastomosis, the immediate and remote effects of bowel operations, and the dangers and results of laparotomy.

Dr. Martin and Dr. Robinson operate at the Woman's Hospital in the presence of the students.

Dr. Martin demonstrates at the school the electrical treatment of fibroid tumors of the uterus and other pelvic diseases.

#### *Surgery.*

At half-past ten every morning Dr. Trott, Dr. Van Hook, Dr. Verity or Dr. McCollum holds a clinic at the school, at which members of the class will be required to make diagnoses, suggest proper treatment and perform as many operations as possible. The theory and practice of antiseptic and aseptic wound treatment will be thoroughly inculcated. The application of practical orthopedic procedures will be carefully taught. Dr. Van Hook takes special pains to study and to demonstrate the pathology of surgical diseases in his service. Morbid specimens obtained in clinical work are studied microscopically by the class. Studies in experimental surgery will be prosecuted, and such matriculates as desire may participate. Dr. McArthur gives clinics at St. Luke's Hospital and Michael Reese Hospital.

Dr. Murphy gives clinics weekly at the Cook County and St. Joseph's Hospitals.

Drs. Steele and Trott hold each a weekly clinic at the Charity Hospital.

Dr. Weber gives three didactic lectures a week on minor surgery.

Dr. Ridlon gives one clinic a week on orthopedic surgery.

#### *Operative Surgery.*

Courses in this department, outside the special course, will consist in instruction in surgical operations upon the cadaver by Dr. Trott and Dr. Tanquary.

#### *Intestinal Operations.*

A systematic course of intestinal operations will be given to classes of three or more, under the direction of Dr. F. B. Robinson. Each student will be taught to do Anastomoses and Enterorrhaphy, and how to construct plates and apply grafts. These experiments are conducted on living dogs.

#### *Diseases of Children.*

Daily clinics will be given on diseases of children, by Dr. Cook and by Dr. Engelmann.

#### *Nose and Throat.*

From 1 to 2 P. M. Dr. Hardie, Dr. Morgenthau and Dr. Owsley. Thorough instruction is given in the use of the laryngoscope, rhinoscope, and other instruments. Every student is afforded ample opportunity to become expert in the use of these instruments and in the diagnosis and treatment of the various affections of the throat and nose. The clinical material is rich and abundant.

Instruction upon intubation is given. The subject is taught by means of a manikin and by cases in private practice. An opportunity is thus afforded each matriculate to become an expert in this important operation.

### Medicine.

A Medical Clinic is held twice a week by Dr. Babcock, at which time he devotes special attention to physical diagnosis. He also gives one medical clinic a week in the Amphitheatre of the Cook County Hospital, and, so far as possible, affords students of the Post Graduate Medical School opportunities for the examination of patients in the wards. Dr. Robison gives two medical clinics a week at the School, with especial reference to general diagnosis. Dr. Lackersteen gives one lecture a week on electro-therapeutics.

### Nervous Diseases.

Beside clinical illustration of diagnostic methods of treatment, including the use of electricity for both purposes, Dr. Brown presents by means of diagrams and dissections such features in the anatomy and physiology of the nervous system as are essential in reaching a diagnosis. Dr. Brown gives one clinic a week at the School and one a week at the Cook County Hospital on diseases of the nervous system, and also gives practical instruction to students who wish to pursue lines of experimental research by operations upon the brains of living animals. Dr. Brower gives one clinic a week at Cook County Hospital upon diseases of the nervous system, also a clinic on Wednesdays and Saturdays at 4 P. M., at St. Joseph Hospital, department of diseases of the nervous system. Dr. Yount gives one clinic a week in this department.

### Venereal and Skin Diseases.

2 to 3. Dr. Baum and Dr. Bishop will give daily clinics at the School.

### Genito-Urinary.

Dr. Hayes gives a medical and surgical course on this subject. An operative course is given when desired.

### Obstetrics.

Dr. Earle will deliver one lecture a week with illustrations and demonstrations on the manikin. The following subjects will be discussed:—Recent discoveries in the Anatomy, Physiology and diagnosis of Pregnancy; Indications for the use of forceps and the operations; Extraction of the breech; Hemorrhages; Version; Induction of Labor; Convulsions, and Cæsarean Section.

### Disease of Rectum.

Dr. Bacon will give two clinics a week at the College and three at the Charity Hospital.

### Urinalysis.

Urinalysis and toxicological chemistry are practically taught by John A. Wesener, Ph. C. The microscope is used in the study of urinary deposits, and practical microscopy is taught when required.

### Pathology.

In connection with the courses in Pathological Histology fresh specimens, of which there is abundance, are demonstrated and studied. Drs. Beck, Dodds, German and Wesener will give daily instruction.

### Histology.

One or more animals are injected and a series of normal histological sections prepared from the tissues and organs. The imbedding, section cutting and staining are done by the students.

### Bacteriology.

A twelve weeks' course in systematic bacteriology will be given to classes of three or more. The course will be divided into terms of four weeks each, one or more of which may be taken at the option of the student.

Daily instruction in small classes will be conducted in the laboratory with special attention to demonstrations and class lectures.

#### FIRST TERM.

Principles of sterilization, inoculation and infection.  
Methods of preparing culture media.  
Action of bacteria upon media.  
Elementary bacteriological biology.  
Coverglass preparations and staining.

#### SECOND TERM.

Bacteriological analysis, including water analysis.  
Advanced methods of staining.  
Principles of bacteriological pathology; experimental inoculation of animals, post-mortems and section cutting.

#### THIRD TERM.

Clinical bacteriology.  
Examination of sputum secretions and excretions.  
Analysis of pus from unopened abscesses and pathological urine.  
Students will be given individual work from the hospital or morgue when available.

### FEES.

A Matriculation fee of five dollars is charged in all cases.

While in our present quarters a general ticket, admitting to all the departments in the fee table, except pathology and operations upon the cadaver, for a four weeks' course, \$50; six weeks, \$75.

A fee of five dollars is charged for diploma of attendance.



The students are admitted to Micheal Reese's Hospital once a week to witness the Surgical Clinics by Prof. L. L. McArthur.

The Illinois Charitable Eye and Ear Infirmary affords a large field for students studying diseases of the Eye and Ear, through the clinics of Prof. Boerne Bettman, given three times a week. These clinics average as high as 50 patients a day.

The Chicago Charity Hospital, with accommodation for 150 patients yearly, is under the exclusive controll of the teachers in the Post-Graduate School. A large out door clinic is conducted with this institution which has an average attendance of 25 patients daily. Clinics are held regularly by Profs. W. F. ### A. Aims of the Division.

The Medical Laboratory Extension Division is a part of the medical laboratories of the Post-Graduate Medical School, and, like them, is under the supervision of the directors of the school. The division was organized with the view of offering medical laboratory instruction to physicians, dentists, chemists and others, who are unable to devote time to the regular resident courses, and also to foster medical culture throughout the city. Laboratory teaching, parallel to that of the medical laboratories, is given in extension form, at such time and place as not to interfere with daily vocation or personal interests, and every arrangement is made to give convenience to those taking the courses. Extension studies are to employ leisure time with subjects both of an interesting and practical nature.

The difficulties of studying alone are recognized; but when there is the expectancy of a class meeting, the interest, the work done and the results are by far more satisfactory. Extension laboratory work is as possible as extension literary study, and is certainly as profitable. The courses of study and all arrangements are directed from the home center at the school, and in a general way the methods and rules of the medical laboratories are followed.

### B. Material Support.

Equipment and organization are the essentials to good laboratory work. The medical laboratories of the Post-Graduate School have

been in full force for several years, and during this time students have been in continual attendance upon the courses. The instruction as given has always had a demonstrative and individual character, the student doing the work himself, and drawing his own conclusions. As the courses of the extension division are in direct conjunction with those given in the medical laboratories, more can be offered than is possible under any other arrangement. Moreover, apparatus is loaned for use in the courses, thus very materially reducing the expense. Material upon which to begin work, and subjects for investigation, are supplied in abundance from the Post-Graduate Hospital, the Dispensary, and from neighboring institutions. In this way an almost complete series of the important facts and demonstrations of medical science may be shown and studied. The demonstrators associated in the division are all practical laboratory teachers, at present conducting classes in the institutions of the city. The laboratory of the Post-Graduate School is furnished with such equipment as the experience of the last two years has demonstrated to be of service in teaching the practical man what he wants in the way of laboratory work. To this equipment, both of apparatus and material for study, the extension student has the same access as the resident student.

### C. Courses of Study.

Each course consists of the class lectures and demonstrations, the time given to indi-

vidual exercise and the collateral reading. A course may be continued as long as desired by that particular class. The material for study is arranged under subjects. During the course any number of subjects may be studied; the time devoted to any subject is left to the desire of the class. Only one subject is to be taken up at a time, unless specially arranged. When more subjects are desired, it is well to have them continue in sequence, as higher topics and more advanced technique will be better appreciated.

It is not intended that the individual exercise be restricted to the time devoted to a subject, but it may be continued through a subsequent part of the course; but the instruction in that subject will be proportionate to the number of demonstrations. In this way a participant may be following work in two subjects at once.

It is desirable that individual work be undertaken during the intervals of class meetings, as some manipulations will require more time than others for completion.

#### D. Centers and Supplies.

The courses are given at centers throughout the city and suburbs. Permanent centers are not advertised, but such places will be selected, in the immediate neighborhood of the majority of the class, where telephone and transportation facilities are ample enough to cause the least inconvenience. Such arrangements may be made by the class or the Division. All of the courses are given in the evening, in general the time being from 7:30 until 11 o'clock. The number of meetings during the month is left to the desire of the class.

The apparatus for the practical work is supplied in the form of *outfits*. These outfits contain material and apparatus enough for the entire class to do the work of one subject. Individual outfits are not issued unless specially arranged. Each outfit is made up for a subject, and not for a course. When a new subject is taken up by the class the outfit will be rearranged to accord with the new work. The

outfits are supplied by the Division from the medical laboratories. An apparatus list accompanies each outfit, and indicates what portion is to be returned and also the charge for breakage. The Division reserves the right to remove larger pieces of apparatus for use in other courses. Outfits are delivered and returned by the agents of the medical laboratories. Light, heat and incidentals are arranged by the Division.

#### **E. How to Organize a Course.**

It is desired that those wishing to organize a course shall feel free to make arrangements suitable to themselves. It is preferable for a number of persons to decide upon a course, and then make arrangements with the Division. The class should be organized something upon the principle of a club. The Division may be informed of a possible center, and a course will be arranged, provided enough persons can be interested. The Division will send a demonstrator to confer regarding courses and subjects, who will also assist in finding centers or in completing other arrangements.

#### **F. Credit.**

Credit for work done will be given under the regulations of the Post-Graduate Medical School. When credit is desired, it should be announced early in the course, and an outline of requirements will be furnished. As an examination, it is required that a thesis of not less than five hundred words be prepared relating

to some part of the course or to an investigation pursued. These are required only from those desiring credit; but it is desired that as many be prepared as possible. The journal of the school, the *NORTH AMERICAN PRACTITIONER*, offers a means of publication. Certificates are issued by the School.

#### **G. Fees.**

No fewer than eight class meetings and demonstration will be considered.

A course of eight meetings can include more than one subject only under special circumstances.

When a course is arranged it must be decided what subjects are desired, and the length of time that each shall occupy.

Courses may be extended, but always with a definitely agreed limit.

It is intended that ten participants constitute a class.

If at the end of the prescribed course six participants desire to continue the work, they may do so under the usual rating of the fee-table.

The fee for the courses is based upon an individual fee of 75c. for each meeting.

An individual breakage and material fee of \$2.00, to be returned in part, is deposited on the outfit.

Anatomical material will require a special fee, not returnable.

All fees are payable in advance.
