Revised Senate Bill #24 on Unemployment, in which the late Dr.Henderson was interested, was passed by the Senate yesterday, and according to arrangement, is doubtless being introduced in the House to-day by Representative Michael L. Igoe of Chicago.

Mr. Igoe is in the University district, and I am taking the liberty of writing you to ask if you will use your influence with him by letter or telegram, urging him to do everything in his power to secure special consideration for this bill as a sort of emergency measure. It is possible to push it ahead of its rank during the next few days if pressure is brought upon the proper officials.

May I suggest further that you wire or write Speaker Shanahan on the subject.

The bill in its present form is not as good as the original, but it was found necessary to withdraw the civil service feature in order to secure the other benefits, since the present House is radically opposed to further extension of civil service at the present time. Most of the other good features of the original bill are retained, with the net result that if passed, the state employment system in Illinois will be at least fifty per cent better than it is now. The bill gives broad powers to the advisory boards to be appointed, both in the way of increasing the every day efficiency of the work as well as doing things which will reduce the ever recurring slack periods.

Some other persons and I who have been pushing the bill will go down to Springfield Sunday evening to do whatever personal work on it we can.
