

The receipt of your letter of March 29 in regard to faculty tuition rates in the High School is acknowledged.

In my judgment the faculty tuition rate should not be given to persons who are appointed for less than one year. This means that instructors who are appointed for one Quarter only are not entitled to the rates, even for the Quarter of their appointment. If your practice has been inconsistent with this ruling. I advise you not to disturb the status que, but I should discontinue the practice.

My dear Mr. Woodward:

The following questions have arisen in connection with the adjustment of faculty rate tuition in the University High School:

- 1. Should University instructors who are appointed for only one quarter receive faculty rates for that quarter only, or should they receive the rates for the entire year? 70.
- 2. Does an appointment in the University College entitle a person to faculty rates?

The two cases in question are William F. Rasche, who was appointed for the autumn quarter in the School of Education, and who gave a course in the University College during the winter quarter; and Edward N. Wentworth, who holds an appointment in the School of Commerce and Administration for the spring quarter and who gave a course in the University College during the autumn quarter.
