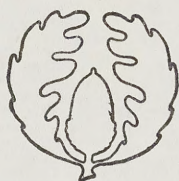

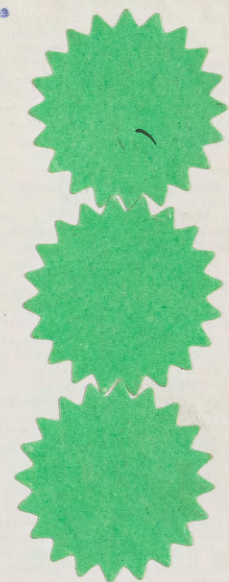

Dear Miss Talbot:

We have your favor of August 8 referring to the royalty report on "The Education of Women." It is true that the statement of copies on hand June 30, 1911 does not agree in the two reports. After the report of June 30, 1911 was made, it was found that our records showed that fifty copies had been placed on sale with the Baker and Taylor Company, of New York, but that this entry was in error and should have read twenty-five. Since the statement of copies on hand at that date was made up from an actual inventory of our stock on hand, it was necessary to make this correction in the "on sale" copies to avoid an error in the records of the total number of copies in making our statement of June 30, 1912. This correction was therefore made, and we neglected to notify you of the reason for the difference. You have received full credit for royalty on all copies sold.

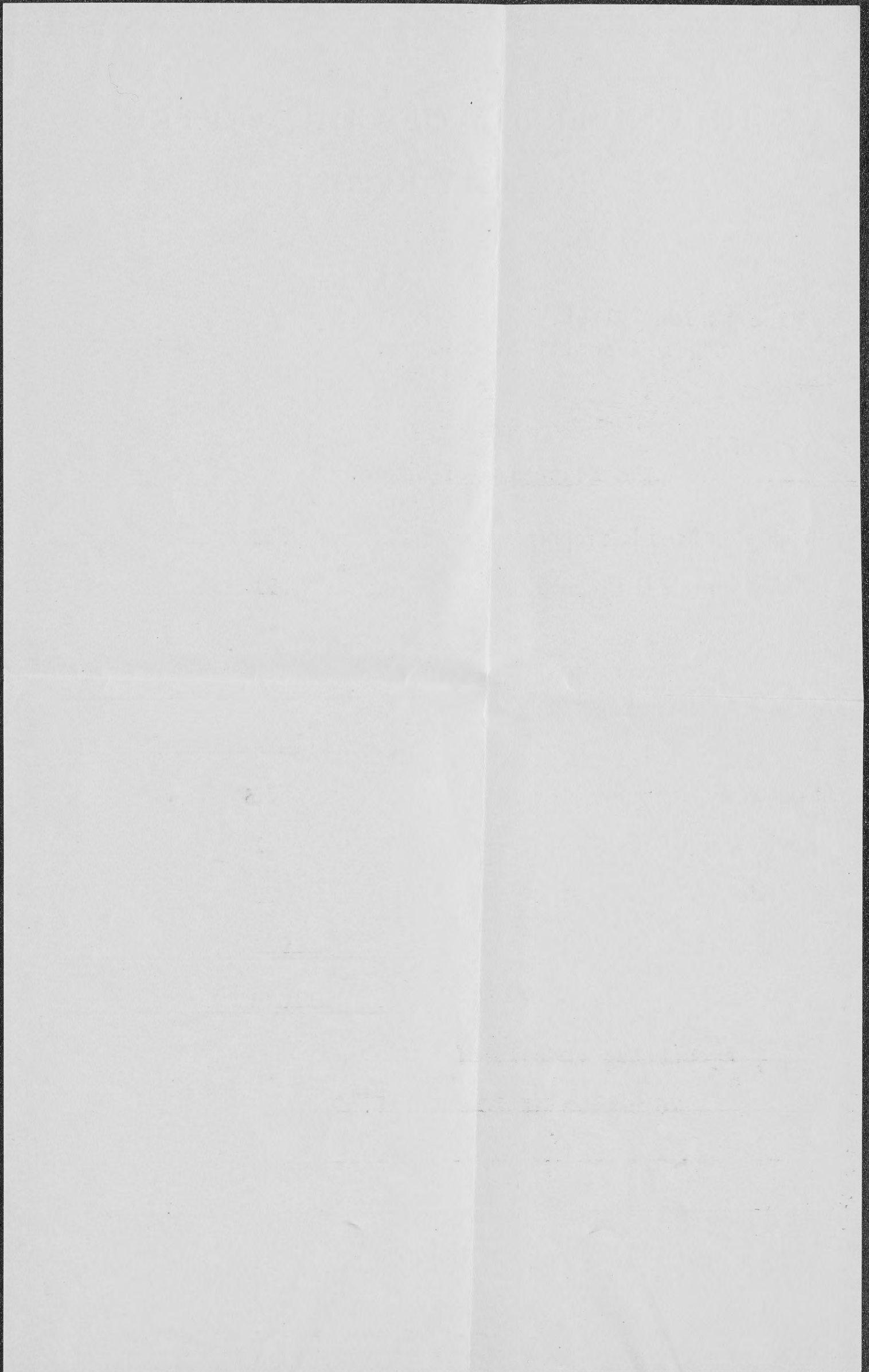

Dear Miss Talbot:

We are in receipt of your favor of August 1 with reference to the disposition of the remaining stock of your book. You were right in your understanding that we have disposed of all of the stock, but it is not true that the book has been taken out of the market. As a matter of fact, it will be given new life since it has been taken over by a firm in New York which makes a specialty of the sale of remainders, the demand for which through the regular market has practically ceased. The situation in the case of your book is one which publishers are constantly confronted with, and it is to provide for such a situation that the clause in the contract under which we have acted is provided. We find it necessary to take this action in the case of a number of the titles in our list every year. The fact that during the past fiscal year not a single sale of your book has been made, and that sixty-three copies previously reported as sales had been returned, made it imperative that it be added to the remainder list. The notation on the royalty report sent you referred to the returned copies noted above. A royalty of \$7.88 had been paid you on these copies, and under the regular procedure the amount would be deducted from any future royalty payments. Under the circumstances, however, we are eliminating this item from our books and squaring the account.

Something over seven hundred copies were disposed of to McDevitt-Wilson, Inc., 30 Church Street, New York City, and copies may be secured from them at a nominal price. We also still have on hand the plates, which if you care to preserve for possible future printings, we will be glad to sell to you at the value of the metal, which is \$17.50. We will be glad, however, to have a prompt decision on this point since we are planning to sell these along with other book plates for old metal at an early date.

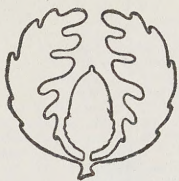

MEMORANDUM OF AGREEMENT, in duplicate - - - , made  
this first (1st) - - - - - day of April - - - - -  
nineteen hundred thirty-six - - - - - , A.D., 1936 , between  
THE UNIVERSITY OF CHICAGO, a corporation organized and doing busi-  
ness under the laws of the State of Illinois, of Chicago, Illinois (hereinafter  
referred to as the "University"), its successors and assigns, party of the first  
part, and MISS MARION TALBOT of Chicago, Illinois - - - - -  
- - - - - (hereinafter referred to  
as the " Author ") her- heirs, executors, administrators,  
and assigns, party of the second part, WITNESSETH:

In consideration of the covenants and agreements of the University as  
hereinafter set forth, the Author - - - - - covenants and agrees with  
the University as follows:

1. To grant and assign and she- does hereby grant and assign to the  
University the sole and exclusive right to publish both in the United  
States of America and elsewhere in book form and in accordance with  
the terms hereof, a work now entitled: MORE THAN LORE:  
Recollections of the University of Chicago - - - - -

or such modification of title as may be agreed upon in writing by the  
parties hereto.

2. That she is - - - - - the sole author - - and owner of  
the said work and has - - full power to make this agreement and  
grant; that the said work has not heretofore been published in book  
form; that it is innocent and contains no matter libelous or otherwise  
unlawful or which infringes any proprietary right at common law  
or any statutory copyright; that she - will hold harmless and in-  
demnify the said University against any and all suits, claims, de-  
mands, or recoveries, including damages, costs, expenses, and attor-  
neys' fees, which may be made, taken, or incurred at any time by or  
against the said University by reason of any violation of proprietary  
right or copyright, or of any unlawful matter contained in said work  
or occasioned by any other failure on the part of the said author - ,  
of her - representations, covenants, or agreements in this con-  
tract contained; that the copyright to the said work shall be taken  
out in the name of the University, and the University is hereby  
authorized to take all steps to procure such copyright; that the said  
copyright, when obtained, shall be assignable by either party to the  
other on demand when necessary for bringing, defending, or main-  
taining any action under the terms of this agreement, it being under-  
stood that after the termination of such action the copyright shall,  
upon demand, be reassigned to the University.

3. To deliver to the University, on or before the date hereof - -  
- - - - - , the manuscript for the said book,



not to exceed two hundred forty-six (246) pages when  
~~xxxx~~ set in type in the format agreed upon - - - -

and in such state as to be satisfactory to the General Editor of the  
 University Press for publication.

4. To pay to the University at the current rates charged by its University Press, for all alterations in galley and page proofs of the said book in excess of ten per cent (10%) of the cost of the original composition thereof, said payments to be made as follows: within thirty (30) days after the completion of the said volume - - - - -

as evidenced by the invoice of the said University.

5. To revise the first and subsequent editions of the work and to supply any new matter necessary from time to time to keep the said work up to date, as may be desired by the said University; and provided that if the author - - shall neglect or be unable to so revise or supply such new matter as above referred to, the University may engage some other person or persons to so revise or to so supply such new matter and may deduct the expense thereof from royalties accruing to the author - - on such revised or extended editions, it being understood that if such revisions or extensions be not made by the author - - the University shall cause such fact to be evident in the revised or extended edition; and that she - will promptly read and return all proof sheets of all matter composed and will promptly prepare such indices and other similar matter as may be required by the said University in connection with the publishing of the said work.

6. That the author - - - - - will not, during the continuance of this contract, furnish to any other publisher any work on the same subject of competing character or material therefor unless and until she - - shall have offered such work to the said University who shall have, and is hereby given and granted, an option of thirty (30) days thereafter for the acceptance for publication thereof upon terms mutually agreeable to the said parties.

In consideration of the foregoing covenants and agreements on the part of the author - - - - - , the University covenants and agrees with the author - - - - - as follows:

7. To publish the said work at its own expense, through its University Press, in such style or styles as it deems best suited to its sale, within sixty (60) days after revised page-proofs are returned for presswork, except for loss of time occasioned by strikes, transportation delays, fire, shortage of paper stock, and other materials entering into said



work, and all other contingencies beyond the reasonable control of the University affecting the manufacturing and publishing of said work.

8. To pay to the Author - - - - - , during the continuance of this agreement, a royalty of ~~twelve, one-half per cent (12½%) of the retail published price of the said book on all copies sold and for which receipts have been collected, except that the royalty on sales through foreign agencies shall be~~ per cent (10%) of the retail published price; ~~the net receipts on all copies sold except on advance alumni subscriptions taken at the special advance price.~~

it being understood that no royalty shall be paid on free copies furnished to the author - - - - - , or copies used for promotion of sales, review, advertising, samples, or like purposes, or on damaged copies, and that sales statements shall be made annually for the fiscal year ending June thirtieth (30th) in each year, and that royalty payments due as set forth in such statements shall be made on or before August fifteenth (15th) following.

9. To present to the author, ten - - - (10) free copies of the said work upon publication; it being understood that additional copies will be supplied at the regular wholesale rate prevailing at the time of such purchase.

It is mutually understood and agreed between the parties hereto as follows:

10. That the University reserve the right after three (3) years from the date of the first publication of the said book, in the event that the said University considers the said book to be no longer merchantable or profitable or desirable, to discontinue the title in its list, to discontinue the publication of the said book and to terminate this contract, provided, however, that the University shall first give to the author, as hereinafter provided, three (3) months' prior notice of its intention so to do. Upon the termination of this contract as aforesaid, and in the event that the University Press cannot sell the remaining stock of the said book at more than the cost of paper, printing, and binding, plus royalties and all other costs incident thereto, the University shall have the right to dispose of all copies on hand for waste paper or at such price as it may be able to obtain and to be relieved from the payment of royalties as provided above on any of the copies disposed of as in this article provided.

11. That in every case where, under the provisions of this agreement, it shall be required or permitted for either party to give or serve any demand or notice to or upon the other party hereto it shall be sufficient: To deliver or cause to be delivered a written or printed copy of any such demand or notice to the said party, or to send a written or printed copy of such notice or demand by registered mail, with postage prepaid and duly addressed to "The University of Chicago Press, Fifty-seven Fifty (5750) Ellis Avenue, Chicago, Illinois," and to the Author at Fifty-seven Seventeen (5717) Kimbark Avenue, Chicago, Illinois - - - - - at such other place as either party may so designate to the other or by written notice.

Assuring you of the pleasure it has been for us to work with you in this connection, we remain

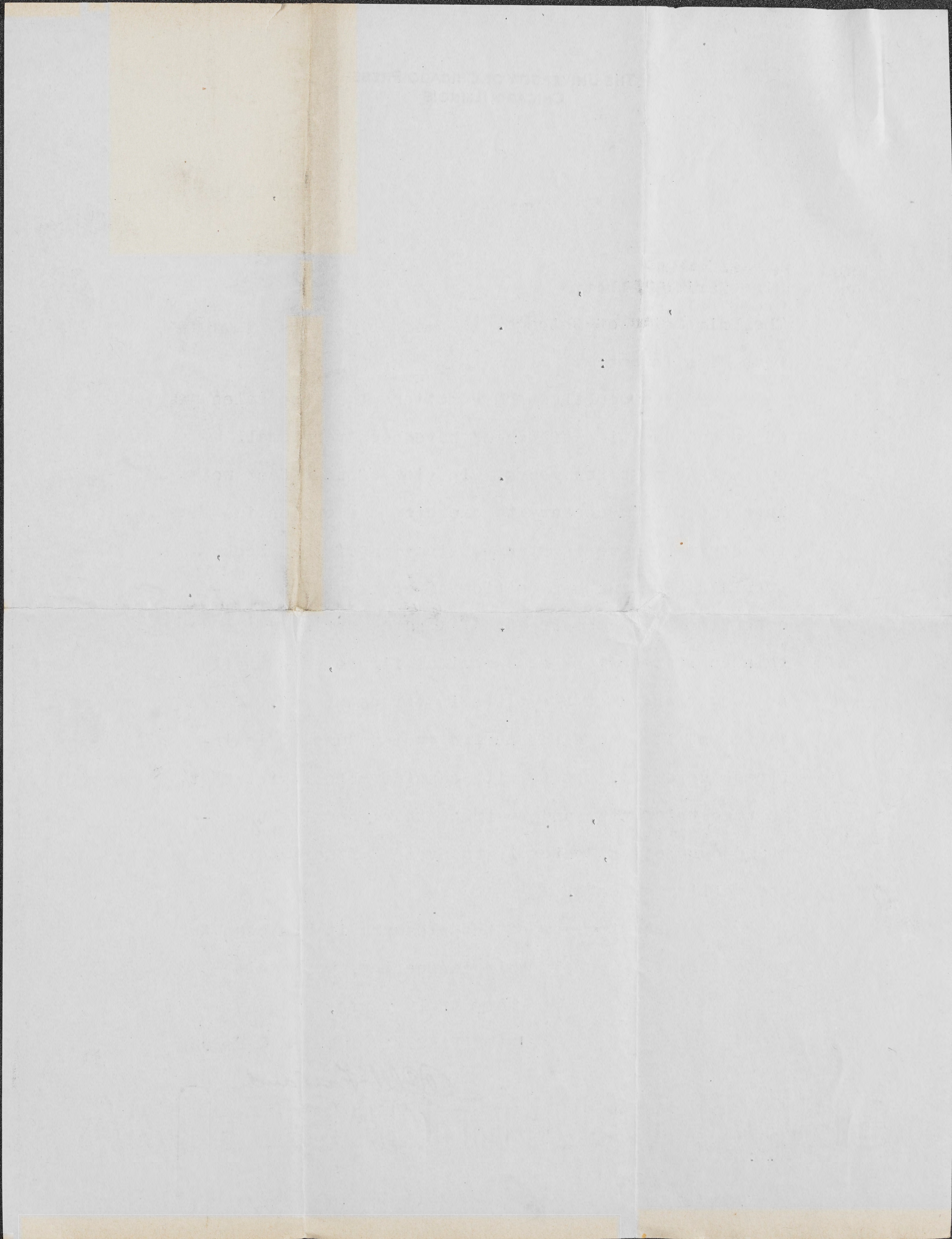

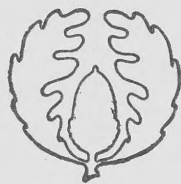

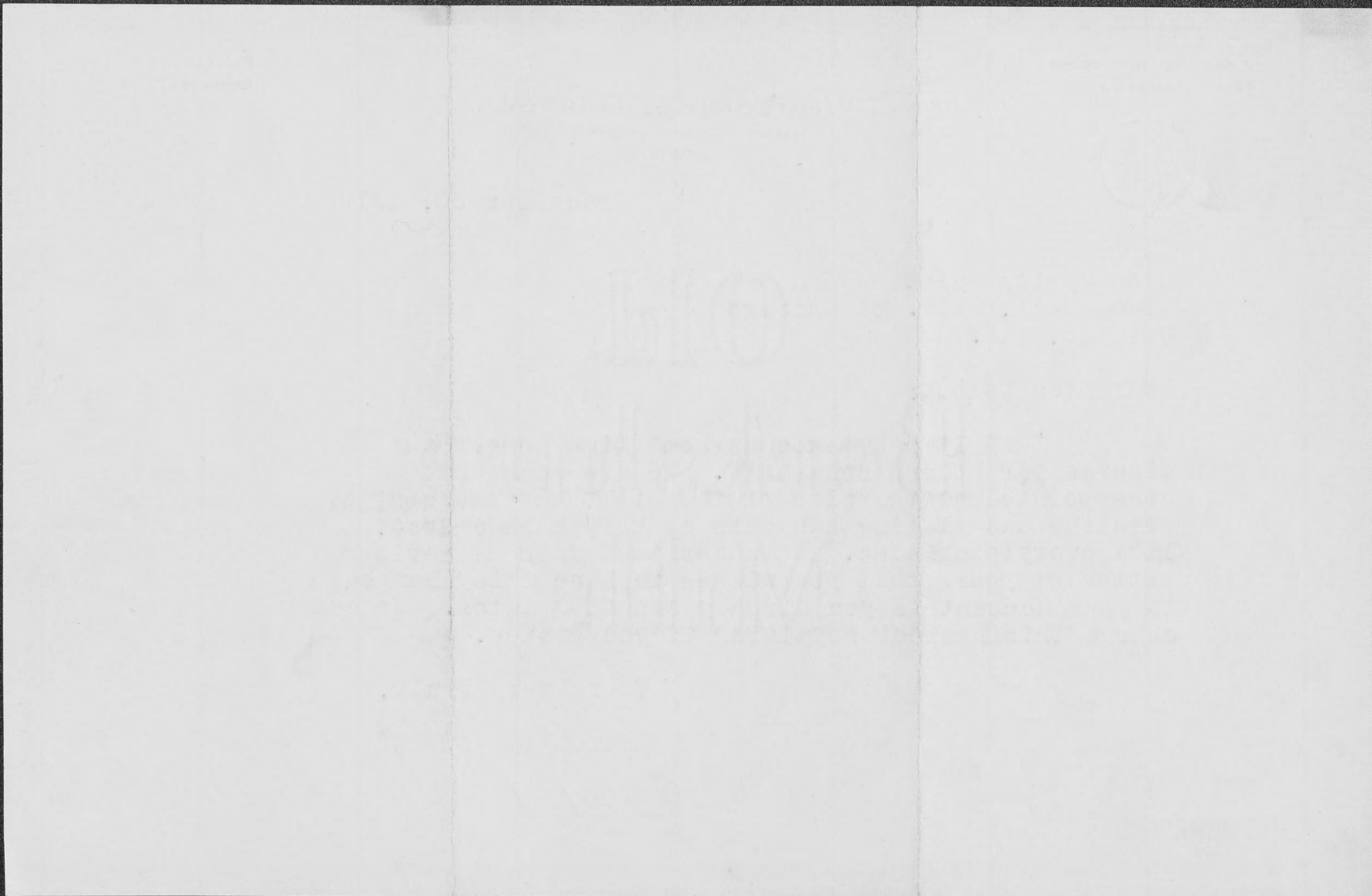
Dear Miss Talbot:

MEMORANDUM OF AGREEMENT - in duplicate - made

WITNESSETH:-

That the University of Chicago, party of the first  
part, for and on account of its University Press, hereby  
agrees with Marion Talbot, author and proprietor of a  
book entitled "The Education of Women," or such modification  
of title as may be mutually agreed upon, to manufacture  
and publish said book in accordance with the specifications  
and stipulations hereinafter set forth, viz:-

1. To pay the cost of manufacturing said book, an item  
which shall include the cost of composition, stock,  
presswork, binding, etc.
2. To pay for marketing said book, an item which shall  
include all office and other charges of whatsoever  
nature, which shall be deemed necessary by the  
party of the first part for promoting the sale of the  
said book, and to keep the market supplied with  
said book so long as there shall be a reasonable  
demand for the same.
3. To pay to the party of the second part or her  
legal representatives annually during the con-  
tinuance of this agreement, a royalty of 10% of  
the published price of said book for each and every  
copy sold.

In consideration of the faithful performance of  
the foregoing agreement on the part of the University of  
Chicago, party of the first part, the said Marion Talbot,  
party of the second part, has agreed and does hereby agree  
as follows, viz:-



1. That she does hereby bargain, sell and assign to the said party of the first part, its successors or assigns, the exclusive right to manufacture and publish said book during the full term of the copyright thereof, and also during the full term or terms of any and all renewals of said copyright, hereby covenanting with the party of the first part that she is the sole author and proprietor of the same, agreeing to protect and defend the said party of the first part in the publication of said book against loss whether incurred in a suit or other action at law, or in any way resulting from any libel or infringement of copyright said book may be alleged to contain.
2. That she will not, without the consent in writing of the party of the first part, write, print or publish, or cause to be written, printed or published, during the continuance of this agreement any other edition of said book, or be pecuniarily interested in any book of the character of said book liable to interfere with the sale of the same.
3. That she will read all proof sheets of said book, with the understanding that she will pay to the party of the first part the cost incurred in making corrections at variance with the original copy which shall be in excess of ten per cent. (10%) of the cost of the original composition of said book.
4. That upon receipt of page-proofs from the party of the first part she will promptly prepare an adequate index for said book or authorize the preparation of the same by the party of the first part at her expense.

It is mutually understood and agreed between the parties hereto as follows, viz:-

1. That statements of royalty-bearing sales shall be made annually in the month of July for the transactions of the preceding calendar year ending June 30, and that the royalties thereunder shall become payable on or before the Fifteenth (15th) day of August of each year.
2. That if at any time after said book shall have been published two (2) years the said party of the first part cannot sell the book to the trade or otherwise at the cost of paper, printing and binding, the said party of the first part shall have the privilege of disposing of all copies on hand for waste paper or at some price less than cost of paper, printing and binding, and thereupon terminate, cancel and annul this agreement without paying to the party of the second part the sum of money provided for in Article 3 of the agreements of the party of the first part, or any other sum as copyright royalty on any of the copies sold without profit as in this article provided.



3. That no royalties shall be due or payable on free copies given away for the promotion of the sale of said book.
